I have appointed Klejdi Gjurma as the company safety officer with particular responsibility for the company's health, safety and welfare systems and to whom reference should be made in the event of any difficulty arising in the implementation of this policy and who shall be responsible for maintaining all necessary information, training and supervision to all employees and sub-contractors to ensure effective implementation of this policy.
